# **WASTE MANAGEMENT POLICY**

BBW is committed to effective waste management practices aimed at minimizing environmental impact, promoting resource efficiency, and ensuring compliance with applicable legal and regulatory requirements. This policy covers waste reduction, sorting, treatment, recycling, hazardous waste management, and contractor oversight.

#### 1. Waste Reduction

BBW will implement internal measures to reduce waste generation at the source through:

- Reusing and recovering scrap metal, equipment, and vehicle parts.
- Repurposing used equipment and facilities wherever feasible.
- Encouraging eco-efficient production processes and lean manufacturing to minimize waste output.

### 2. Waste Sorting and Treatment

Waste generated from BBW operations will be categorized and sorted systematically:

- General Waste: Includes office waste, packaging material, and non-hazardous industrial waste.
- Construction Waste: Debris from facility upgrades and repairs, managed separately.
- Hazardous Waste: Materials posing risks to human health or the environment, including waste synthetic resin, synthetic rubber, wastewater sludge, process sludge, waste acids, alkalis, dust, organic solvents, oils, and asbestos.

Proper waste treatment methods such as reusing, recycling, incineration, or safe disposal will be applied as per legal requirements.

### 3. General Waste

General waste generated from business activities, excluding hazardous or construction waste, will be minimized and segregated. BBW will prioritize recycling and composting where applicable and ensure disposal through authorized contractors.

#### 4. Hazardous Waste

Hazardous waste will be handled in strict compliance with national and international laws. Key practices include:

- Storing hazardous waste in designated and secure containment areas.
- Maintaining waste manifests and Material Safety Data Sheets (MSDS).
- Ensuring only licensed hazardous waste contractors manage transportation and disposal.
- Conducting on-site inspections of waste disposal contractors to verify compliance (desk reviews will not be accepted).

## 5. Recycling

BBW promotes recycling through:

- 1) Reuse or recovery of materials such as scrap metals, plastics, and electronic components.
- 2) Recovery of energy from waste where feasible.
- 3) Utilizing waste as fuel in approved processes to reduce dependency on virgin energy sources.

### 6. Waste Outsourcing and Contractor Oversight

When waste management is outsourced to third parties, BBW will:

- Conduct on-site audits of contractors to ensure proper treatment and disposal methods.
- Verify the licenses and compliance records of waste disposal contractors.
- Maintain documented proof of waste treatment and disposal for internal and regulatory audits.

## 7. Compliance and Monitoring

- Maintain records of waste generation, treatment, and disposal.
- Conduct periodic training for employees on waste segregation and safe handling.
- Review this policy annually to align with legal updates and sustainability goals.

This policy is binding on all employees, contractors, and suppliers engaged with BBW operations. Our commitment to responsible waste management is a key component of our environmental stewardship and sustainability initiatives.
